Important Information

Upon registration, post-dated cheques must be provided, dated for the 1st or 15th of each month (July/Aug), paying for all weeks of camp the child will be attending within that month. Cheques are due upon registering your child in our camps. Spots will not be held until cheques are at the office. (Last day for registration March 24th, 2017) Further, to reserve one's space for summer camp, parents must provide one \$200.00 deposit cheque per child, post-dated for the first day of camp that child will be attending. Should you withdraw from that space without two months (60 days) notice before July 1st, 2017, the deposit cheque of \$200.00 will be deposited. A registration fee of \$25 will be applied for children not enrolled in the program from Sept 2016 to June 2017.

Parents: children are required to bring with them, each and every day, a water bottle, a hat, plenty of lunch and snacks (please be aware, we may not have access to a microwave, and due to allergies, Glenwest is a NO PEANUT zone), swimming suits and towel, sunscreen, proper clothing and footwear for weather and activities, and a back pack to hold it all. If your child requires a life jacket, please be sure to send one at the beginning of each week for your child to wear, or you can store it at centre for the entire time your child attends camp. Please clearly mark all of your child's belongings with their last name to prevent them from becoming lost.

We open at 7am and close at 6pm – Camp runs from 9am – 4pm. There is a fee for late pick-ups – late is anytime after 6pm. There are some days which we may get back later than 4pm and we will do our best to notify you of those days. Please note that the calendar is subject to change due to the availability of bookings and venues as well as weather conditions for certain outings.
